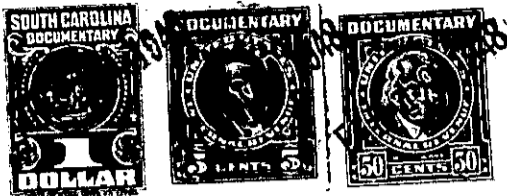

County, State of South Carolina, being known and designated as Lots Nos. 72 and 73 on a
Map of Lincoln Town made by Dalton & Neves, June 1945, and recorded in the R. M. C.
Office for Greenville County, in Plat Book "S", page 39, and having according to

LOT NO. 73: BEGINNING at an iron pin on the East side of Wynette Avenue,
joint corner of lots Nos. 73 and 74, and running thence with
line of lot No. 74, S. 86-0 E., 150 feet to an iron pin, joint
corner lots Nos. 21, 22, 73 and 74; thence with rear line of
lot No. 22, S. 4-0 W., 50 feet to an iron pin, joint corner
lots Nos. 72 and 73; thence with line of lot No. 72, N.
80-0 W., 150 feet to an iron pin on the East side of Wynette
Avenue; thence with Wynette Avenue, N. 4-0 E., 50 feet to
an iron pin, the beginning corner.

LOT No. 72: BEGINNING at an iron pin on the East side of Wynette Avenue,
Joint corner of lots Nos. 72 and 73, and running thence with
line of lot No. 73 S. 86-0 E., 150 feet to an iron pin,
joint corner of lots Nos. 22, 23, 72 and 73; thence with
rear line of lot No. 23, S. 4 - 0 W., 40 feet to an iron
pin on the North side of Watson Street; thence with Watson
Street, N. 86-0 W., 150 feet to an iron pin, joint corner
of Watson Street and Wynette Avenue; thence with Wynette
Avenue, N. 4-0 E., 40 feet to an iron pin, the beginng corner.
