in consideration of the sum of Seven thousand nine hundred and fifty----- DOLLARS,

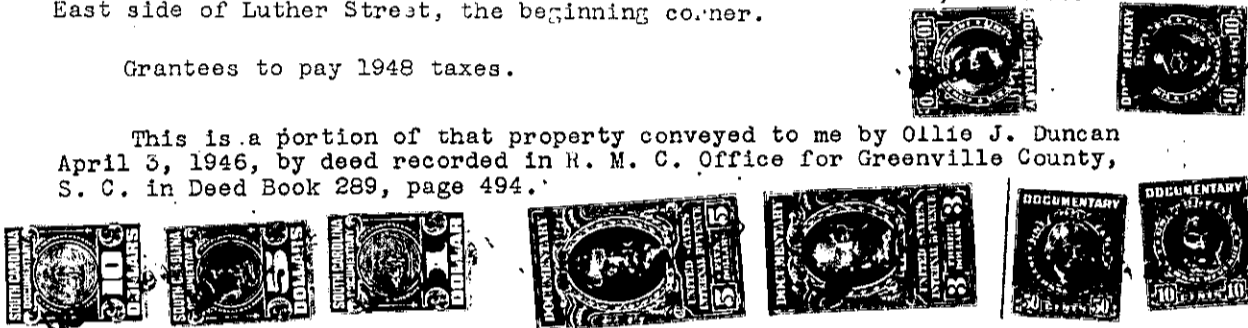
