ments for the government of the Cemetery which may hereafter be adopted.

heirs and assigns, forever; subject, however, to the restrictions and limitations above referred to.

And GRACELAND CEMETERY, INC., for itself, and successors and assigns, covenants with the said
ANDERSON EMANUAL SCARBOROUGH AND LILLIE M. SCARBOROUGH - - - - -
that the lot shall receive general care as specified in Rule No. 5 on the reverse side hercof to which reference is made.

And GRACELAND CEMETERY, INC., does hereby bind itself and its successors to warrant and forever de-
fend the said premises to the said ANDERSON EMANUAL SCARBOROUGH AND LILLIE M. SCARBOROUGH, THEIR
heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to claim
the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
