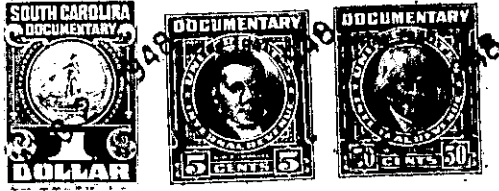

to wit: Beginning at a stake on Rutherford Road, corner of Lot

to corner of Lot No. 11; thence along line of same, N. 66.45 E.
189.3 feet to stake, corner of Lot No. 18; thence S. 23.15 E.
100 feet to corner of Lot No. 8; thence along line of same,
S. 66.45 W. 190 feet to the beginning corner.
