Beginning at an iron pin in the center of the Standing Springs Road, at  
the point where said road is intersected by a County Road, said point  
being 322.5 feet southeast from the intersection of the said Standing  
Springs Road and the Conestee Road (Main Street), and running thence  
along the center of said County Road, S. 44-40 W. 500 feet to a bend in  
said road; thence still with center of said road, S. 55-25 W. 226 feet  
to bend in said road; thence still with said road, S. 49-11 W. 110 feet  
to bend in said road; thence still with said road, S. 34-53 W. 246 feet  
to bend in said road; thence still with said road, S. 57-01 W. 120 feet to  
pin; thence S. 30-44 E. 1220 feet, more or less, to pin in line of prop-  
erty now or formerly belonging to Henry Willimon; thence with line of  
last mentioned property, S. 88-59 E. 1135 feet, more or less, to point  
in center of another County Road; thence with said road, N. 26-38 W. 70  
feet to a bend in said road; thence with center of said road, N. 21-25 W.  
485 feet to a bend in said road; thence still with said road, N. 11-06 W.  
178 feet to a bend in said road; thence still with said road, N. 2-35 E.  
282 feet to a bend in said road; thence still with said road, N. 11-26 E.  
351 feet to bend in said road; thence still with said road, N. 0-56 E.  
200 feet to the center of the Standing Springs Road; thence with center  
of said road, N. 69-02 W. 328 feet to a bend in said road; thence still  
with said road, N. 55-14 W. 438 feet to the beginning corner.

The above described property is a portion of the same property conveyed
