TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the grantee(s) hereinabove named, and Their Heirs and Assigns forever.

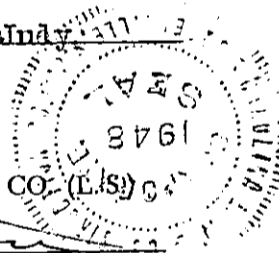
