That I, Eva Good in the State aforesaid, in consideration of the sum of Five Hundred (\$500.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. E. Bowers, his heirs and assigns forever, the following described property:

All that parcel or tract of land situate on the Southwest side of a county road near Lakeside in Gantt Township, Greenville County, S. C., shown as Tract No. 3 on Plat of property of C. C. Good, made by Dalton and Neves, Engineers, May 1940, recorded in the R. M. C. Office for Greenville County in Plat Book L at page 77, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest edge of said county road joint front corner of Tracts 2 and 3, and running thence along the line of Tract 2 (now or formerly belonging to J. H. Causby) S. 12-45 W. 1165 feet more or less to an iron pin at joint rear corner Lots 2 and 3; thence N. 46-30 W. 620 feet to an iron pin; thence N. 32-30 E. 1200 feet to an iron pin on the Southwest edge of said county road; thence with the Southwest edge of said road S. 12-15 E. 300 feet to the beginning corner and containing, according to plat above mentioned, ten acres more or less.

This is a portion of that property devised to me under the last will of my husband, C. C. Good, deceased, and on file in the office of the Probate Court for Greenville County, S. C.

Grantor agrees to pay 1948 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
