

All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, located on the South side of Alaska Avenue, and known and designated as lot No. 4 of Parkview, a plat of which is recorded in the R.M.C. Office for Greenville ounty in Plat Book M, at Page 49, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the South side of Alaska Avenue, which iron pin Is 350 feet East of the Southeastern intersection of Alaska Avenue and Neely Drive (which point is taken by projecting the lines of the two streets since the intersection is a curve instead of a corner,) joint corner of lots Nos. 4 and 5; thence along the joint line of said lots S. 36-17 E., 150 feet to an iron pin, rear joint corner of said lots; thence N. 53-43 E. 50 feet to an iron pin, rear joint corner of lots Nos. 3 and 4; thence along the joint line of said lots N. 36-17 W., 150 feet to an iron pin in the line of Alaska Avenue; thence along the South side of Alaska Avenue S. 53-43 W., 50 feet to an iron pin, the point of beginning.
