to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lorene V. Mullikin, her heirs and assigns forever:

All that certain lot or parcel of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 6 as shown on a plat of the property of E. Godfrey Webster, prepared by W. J. Riddle, Surveyor, March 1948, recorded in Plat Book "U" at Page 79 and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the Southeast side of the Webster Road, joint front corner of lots Nos. 5 and 6, and running thence with joint line of said lots, N. 49-40 E. 192 feet to an iron pin; thence S. 27-03 W. 60 feet to an iron pin, joint rear corner of lots Nos. 6 and 7; thence with joint line of said lots, N. 52-57 W. 199 feet to an iron pin on Webster Road; thence with said Road, N. 35-33 E. 70 feet to the beginning corner. Being one of the lots conveyed to the grantor by Ellison G. Webster, Jr. by deed dated June 23, 1948, recorded in Volume 351 at Page 199.
