Know All Men by These Presents:

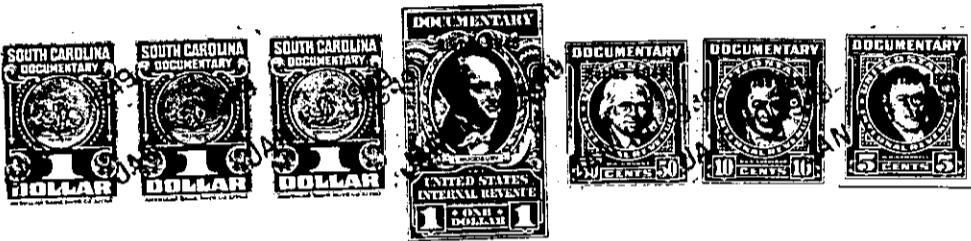

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. S. Everett and Hazel Everett, their heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Grove Road, which point is 183.5 feet from the intersection of Grove Road and Chapman Street, and running thence along the joint line of lot No. 40, N. 22.30 W. 165 feet to an iron pin; thence S. 49.38 W. 56 feet to a stake; thence in a Southerly direction 161 feet, more or less, to a stake on Grove Road; thence along Grove Road, N. 53.10 E. 57 feet to the beginning corner.
