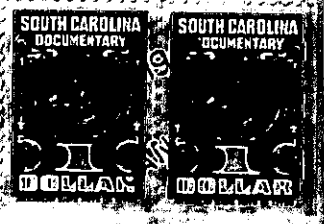
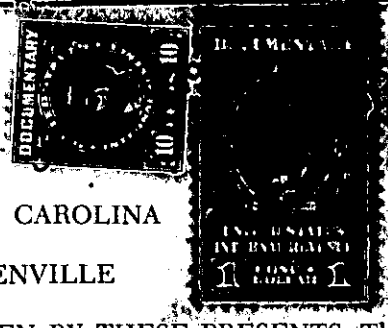

Billingsley, all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as: Lot(s) - - - - - 1, 2 and 3 - - - - - Block - - - - - "B" - - - - - , PINEHURST, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in plat Book S, page 77.
