

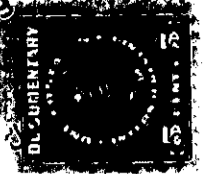

Cox in the State aforesaid, in consideration of the sum of Four hundred and no/100 - - - - - (\$400.00) - - - - - Dollars, to us in hand paid at and before the sealing of these presents by the grantee(s) hereinafter named (the receipt of which is hereby acknowledged), have granted, sold and released, and by these presents do grant, sell and release unto

Dr. J. C. Billingsley, all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as: Lot ~~(2)~~ - - - - - 4 - - - - - Block - - - - - "B" - - - - -, PINEHURST, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in plat Book S, page 77.

This deed is made subject to restrictions applicable to PINEHURST and recorded in the R. M. C. Office for Greenville County, S. C., in deed Book 363, page 499, and further subject to utility easements of record.
