Clarence W. Cooper, All that piece, parcel or lot of land in Greenville Twonship, Greenville County, State of South Carolina, lying and being situate on the Northern side of Northwood Avenue, including the buildings and improvements thereon situate being known and designated as lot No. 9, according to plat of property of Furman C. Smith and G. Herman Walker, recorded im the R.M.C. Office for Greenville County in Plat Book S, at Page 3, and having, according to said plat, the following metes and bounds, to-wit:



BEGINNING at an iron pin on the Northern side of Northwood Avenue, at joint front corner of lots Nos. 7 and 9, said pin being 300 feet Southeast of the Northeast corner of the intersection of Northwood Avenue with Summit Drive; thence N. 1-26 E. 168.5 feet to an iron pin at joint rear corner of lots Nos. 7 and 9; thence S. 87-14 E. 70 feet to an iron pin at joint rear corner of lots Nos. 9 and 11; thence S. 1-26 W. 168.1 feet to an iron pin on the Northern side of Northwood Avenue at joint front corner of lots Nos. 9 and 11; thence N. 87-34 W. 70 feet along said Avenue to an iron pin at joint front corner of lots Nos. 7 and 9, the point of beginning.
