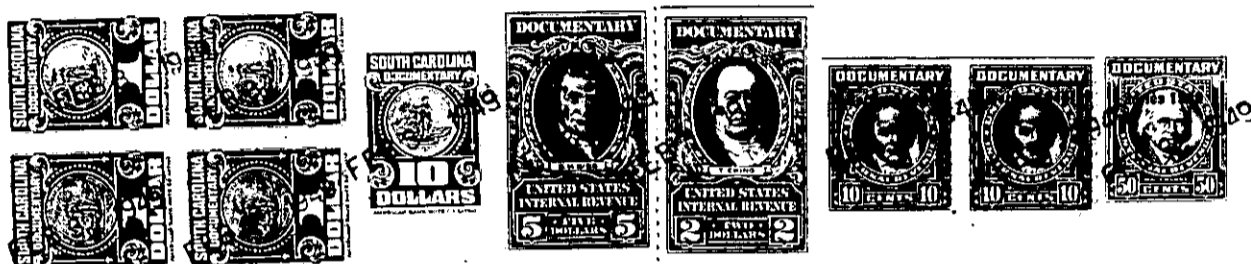
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. D. Christopher and Mrs. Geneva R. Christopher, their heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 9, as shown on a Plat of Property of Nabors and Bridges, prepared by Dalton & Neves, Engineers, July 1945, recorded in Plat Book "O" at Page 195, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin on the North side of Long Forest Drive, joint front corner of lots Nos. 8 and 9, which pin is 505 feet in a Westerly direction from the intersection of Long Forest Drive and Bunc m'ie Road, and running thence with joint line of said lots, N. 7-04 E. 331.6 feet to an iron pin; thence N. 79-30 W. 120 feet to an iron pin, joint rear corner of lots Nos. 9 and 10; thence with joint line of said lots, S. 3-37 W. 336 feet to an iron pin on the North side of Long Forest Drive; thence with said Drive, S. 81-19 E. 100 feet to the beginning corner.
