in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and re-  
leased, and by these presents do grant, bargain, sell and release unto the said City of Greenville,  
a municipal corporation, its successors and assigns, forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State

of South Carolina, lying and being in the City of Greenville on the South side  
of East Faris Road, formerly Blassingame Street, and being known and de-  
signated as a part of Lot 9 of the property of James F. and Lena C.  
Yeager as shown on plat thereof by R. E. Dalton, Engineer, dated Octo-  
ber, 1922 and recorded in Plat Book "F", Page 141, R. M. C. Office for  
Greenville County and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corner of Lots 8 and 9,  
which iron pin is also in the line with property, now or formerly, of  
the J. A. Davenport Estate and running thence along the joint line of  
Lots 8 and 9, N. 26-30 W. 49 feet to an iron pin which is 150 feet, more  
or less, South of East Faris Road, formerly Blassingame Street; thence  
S. 63-03 W. 60 feet to an iron pin in the joint line of Lots 9 and 10,  
which iron pin is 150.6 feet, more or less, South of East Faris Road,  
formerly Blassingame Street; thence along the joint line of Lots 9 and
