to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jessie Hand, his heirs and assigns forever:

All that certain lot of land in Dunklin Township, Greenville County, State of South Carolina, lying on the Eastern side of Cooley's Bridge Road, and being known and designated as tract No. 3 on Plat of the Property of George W. Arnold, made by W. J. Ridle, Surveyor, in December 1948, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Cooley's Bridge Road, at joint front corner of Tracts Nos. 2 and 3, and running thence with line of Tract No. 2, N. 87-43 E. 309.4 feet to an iron pin; thence N. 72-45 E. 231 feet to stone; thence S. 7-00 E. 173.6 feet to stone; thence S. 73-42 W. 561.5 feet to point in center of Cooley's Bridge Road; thence with center of said road, as the line, N. 3-01 W. 279 feet to the point of beginning.
