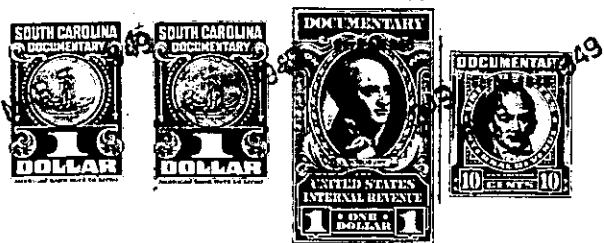
That we, W. M. Shelton and Henry P. Willimon in the State aforesaid,
