BEGINNING at an iron pin on the Northeastern side of Waccamaw Circle corner of Lots No. 97 and 98 and running thence with line of Lot No. 97 N. 48-50 E. 175 feet to an iron pin; thence S. 41-10 E. 75 feet to an iron pin corner of Lot No. 99; thence along line of Lot No. 99 S. 48-50 W. 175 feet to Waccamaw Circle; thence along said Waccamaw Circle N. 41-10 W. 75 feet to the beginning corner.

ALSO all that piece, parcel or lot of land in County and State aforesaid being known as Lot No. 99 of Sunset Hills, according to Plat above described, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Waccamaw Circle corner of Lots No. 98 and 99 and running thence with line of Lot No. 98 N. 48-50 E. 175 feet to an iron pin; thence S. 41-10 E. 75 feet to an iron pin corner of Lot No. 100; thence along line of Lot No. 100 S. 48-50 W. 175 feet to Waccamaw Circle; thence along said Waccamaw Circle N. 41-10 W. 75 feet to the beginning corner.
