Know All Men by These Presents:

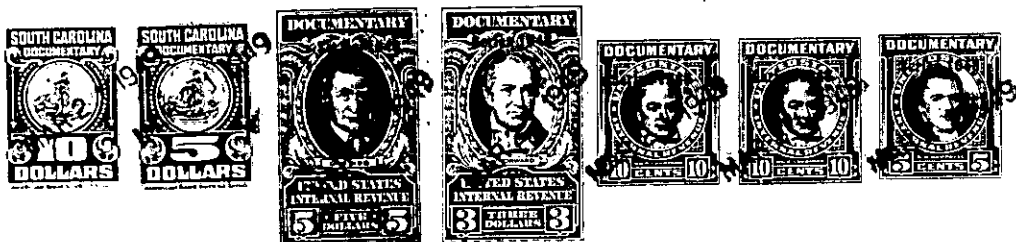
That I, Walter Heath in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John L. Gabrels, his heirs and assigns forever:

All that lot of land near the City of Greenville, County of Greenville, State of South Carolina, being shown as lot No. 29 on Map No. 2 of Camilla Park, made by W. J. Riddle in December 1943, recorded in Plat Book "M" at Page 85, in the R. M. C. Office for Greenville County, and being more particularly described as follows:

BEGINNING at a stake on the Eastern side of White Horse Road, 590.2 feet North from Welcome Avenue at corner of lot No. 30, and running thence with line of said lot, S. 80-44 E. 200 feet to a stake at corner of lot No. 40; thence with line of said lot N. 9-16 E. 80 feet to a stake at corner of lot No. 28; thence with line of said lot, N. 80-44 W. 200 feet to a stake on White Horse Road; thence with the Eastern side of White Horse Road, S. 9-16 W. 80 feet to the beginning corner.
