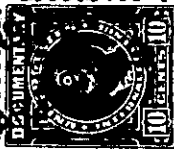
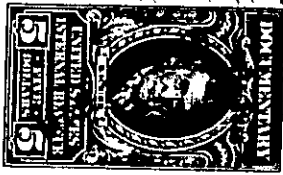

Beginning at the Southeastern intersection of E. North Street and
Boyce Avenue, said point being on the South sidemof said E. North starr
street, and rinning thence along the East side of Boyce Avenue S 15 E
126 feet and 1 inch to the North side of a ten foot alley; thence along
said alley N 76.45 E 71 feet and 8 inches to corner of lot No. 2;
thence along the line of that lot N 15 W 126 feet and 1 inch to E. North
street; thence along the South side of said street S 76.45 W 71 feet
and 8 inches to the beginning corner.

Also all that other lot of land adjoining the above, being lot No.
2 as shown on plat above referred to and more particularly described as

point is the corner of Lot No. 1 as shown on plat above referred to and
runs thence along the line of lot No. 1 S 15 E 126 feet and 1 inch to

alley N 76.45 E 66 feet and 8 inches to corner of lot No. 3; thence along
the line of that lot N 15 W 126 feet and 1 inch to the South side of
