to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Glyde Glenn, his heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Dover Street, near the City of Greenville, being shown as the Northern portion of lot No. 50, as shown on Plat of the Property of Edgar C. Waldron, recorded in Plat Book "B" at Page 171, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Dover Street, at joint front corner of lots Nos. 50 and 51, and running thence with line of lot No. 51, N. 86-04 E. 150 feet to iron pin in rear line of lot No. 48; thence with line of lot No. 48, S. 3-56 E. 35 feet to iron pin at corner of property of A. M.
