Quay and Ella M. Quay, their heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the South side of Potomac Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot #243 on plat of Pleasant Valley, made by Dalton & Neves, April 1946, revised May 1948, recorded in R. M. C. Office for Greenville County, S. C. in Plat Book P, page 93, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, February 21, 1949, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Potomac Avenue, at joint front corner of Lots 243 and 244, said pin being 35 feet West from the Southwest corner of the intersection of Potomac Avenue and Long Hill Street, and running thence with the line of Lot 244 S. 0-08 E. 160 feet to iron pin; thence S. 89-52 W. 60 feet to iron pin; thence with line of Lot 242 N. 0-08 W. 160 feet to iron pin on South side of Potomac Avenue; thence with South side of Potomac Avenue N. 89-52 E. 60 feet to the beginning corner.

The above described property is the same conveyed to the Grantors by W. M. Hughes, by deed dated February 25, 1949, recorded in R. M. C. Office for Greenville County, S. C. in Deed Book 374, page 95.

The grantees assume and agree to pay that mortgage given by Charles A. Trimble and Caroline E.
