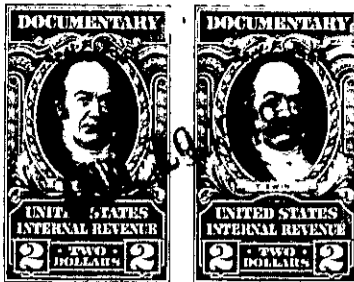

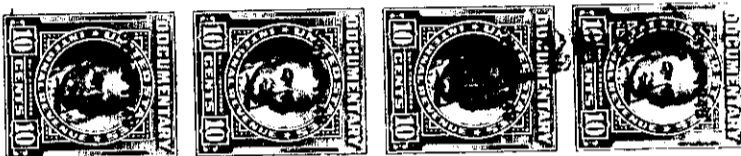

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said ... O. L. Jones, his heirs and  
assigns,



all that piece, parcel or lot of land in Gantt Township, Greenville

County, State of South Carolina, being all of Lot Number Five (No. 5), the eastern  
portion of Lot Number Four (No. 4) and the southern portion of Lot  
Number Six (No. 6), same being all of Lot No. 6 south of White Horse  
Road Extension excepting portion of said Lot No. 6 conveyed by us to  
Campbells, all of same being in Unit Number Three (No. 3) on a plan of  
Pine Crest Farms subdivision, revised by W. J. Riddle, Surveyor, July  
25, 1939, recorded in Plat Book "M", page 3 in the R. M. C. office of  
Greenville County, and, according to said plat, in part, having the  
following metes and bounds, courses and distances, to-wit:

BEGINNING at a point on the northern side of Springbrook  
Drive, joint front corner of Lots Nos. 5 and 7 of said plat, thence  
thence N. 0°38' W. 235 feet, more or less, along the western line  
of Lot No. 7 to point on southern right of way line of White Horse  
Road Extension; thence in a westerly direction, 292 feet along  
southern right of way line of said White Horse Road Extension, to  
joint corner with lot heretofore conveyed by us to Campbells;  
thence S. 0°38' E. 132 feet along the eastern line of said lot to  
point on northern side of Springbrook Drive; thence S. 0°38' E. 132  
feet along the northern side of Springbrook Drive, to the beginning.

and Edith M. Brock by J. W. Moose and Daisy Mae Moose by deed dated
