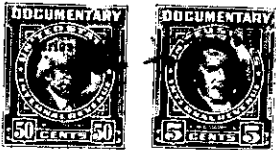
That W. M. Shelton and Henry P. Willimon in consideration of the sum of Five Hundred (\$500.00) ----- DOLLARS,
