

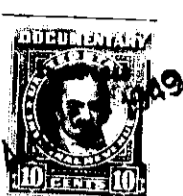

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, located on the North side of North Main
Circle, in the Town of Simpsonville, being known as lots # 22 and 23 of the subdivision known as Traylor's Addition
according to a plat made by W. J. Fiddle, Surveyor in Charge, 1908,
said plat being recorded in the Public Office of Greenville
County in Plat Book "K" at pages 111 and 112, and listing according
to said plat the following notes and bounds, to-wit:

Lot # 22
BEGINNING at an iron pin on the north side of North Main Circle
at the southeast corner of lot # 21 and running thence North 70-15
North side of said circle, E. 70-15 N. 90 ft. to corner of lot
23; thence with line of lot # 23, N. 17-01 W. 200.5 ft. to
pin; thence S. 70-15 W. 100 ft. to corner of lot # 21; thence
with line of lot # 21, S. 19-45 E. 200 ft. to the southeast
corner.

Lot # 23
BEGINNING at an iron pin on the North side of North Main Circle,
corner of lot # 22, and running thence North 17-01 W. 200.5 ft.
N. 17-01 W. 200.5 ft. to an iron pin; thence N. 70-15 E. 90 ft.
to an iron pin, corner of lot # 24; thence with line of lot # 24,
lot S. 7-00 W. 248.5 ft. to an iron pin on North Main Circle;
thence with said circle E. 86-45 S. 30 ft. to the southeast corner.

by J. C. Berry in the deeds dated Aug. 2, 1908, recorded in
the Greenville County R. M. C. Office in Vol. 334, page 293 for
lot # 22, and in Vol. 364, page 293 for lot # 23.
