KNOW ALL MEN BY THESE PRESENTS, That I, ^(or we) ~~OLLIE FARNSWORTH~~ Lydia McA. Christman, Mary
 McA. Apperson, Sophie McA. Stokes and Esther McA. Fleury

SEVEN HUNDRED TWENTY EIGHT & NO/100 DOLLARS

in consideration of the sum of ~~(\$728.00)~~ to me (or us) in hand paid, and other valuable consid-
 eration at and before sealing and delivering hereof, by the City of Greenville, South Carolina, receipt of which is hereby
 acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain sell, and release
 unto the said City of Greenville, South Carolina, its successors and assigns, a right-of-way for the construction of a
 section of the street on East side of Rutherford Street

in the City of Greenville, State and County aforesaid, for the purpose of locating, constructing, improving, and main-
 taining the above described street. Bounded (1) by lands of Triune Methodist Church on the
 North, other lands of the grantors on the East, W.T. Martin on the South and
~~by lands of Rutherford St. on the West. (2) W.T. Martin on the North, other lands~~
 of the grantors on the East, Salibrich Farroh on the South, and Ruther-
 ford Street on the West.

Described as follows: All that piece, parcel or strip of land on the East side
 of Rutherford Street in the City of Greenville, S.C., beginning at the
 common corner between the property of the Chas. McAlister Estate and that
 of W.T. Martin and running thence North along Rutherford Street 57.2 feet
 to the common corner between the property of the McAlister Est. and that
 of Triune Methodist Church, thence Easterly along the McAlister and Triune
 M.E. Church property line 8.6 feet, thence South across the property of
 the Est. of Chas. McAlister 56.2 feet to a point on the McAlister Est.
 and the Martin property line, thence Westerly along said line 10.4 feet
 to the point of beginning on Rutherford Street.

ALSO: All that piece, parcel or strip of land on the East side of Ruther-
 ford Street in the City of Greenville, S.C., beginning at the common
 corner between the property of the Chas. McAlister Estate and that of
 Salibrich Farroh and running thence North along Rutherford Street 65.5
 feet to the common corner between the property of the Chas. McAlister
 Estate and that of W.T. Martin, thence Easterly along the McAlister and
 Martin property line 13 feet to a point, thence South across the property

 McAlister and Farroh property line, thence Westerly along said property
 line 14.8 feet to the point of beginning on Rutherford Street.
