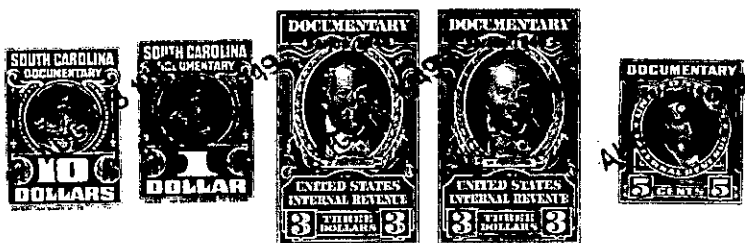

All that certain piece, parcel or lot of land situate, lying and being in Butler Township, in the county of Greenville, state of South Carolina, being shown as Lot 58 on Plat of College Heights made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County, S. C. in plat book "P" at page 75, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Griffin Drive at joint front corner of Lots 58 and 59, and running thence with the line of Lot 59 S. 56-50 W. 150 feet to an iron pin; thence N. 33-10 W. 70 feet to an iron pin; thence N. 56-50 E. 150 feet to an iron pin at the corner of Lots 57 and 58 on Griffin Drive; thence along Griffin Drive S. 33-10 E. 70 feet to the beginning corner.
