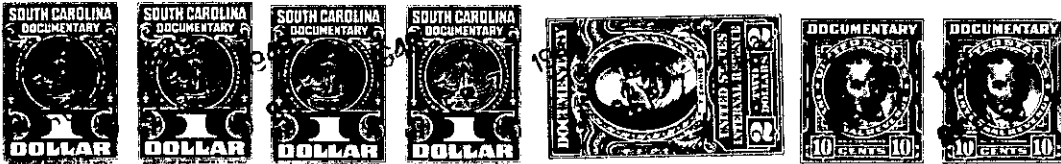

C. Mungo and Fannie Mae A. Mungo, their heirs and assigns, all that piece, parcel or lot

of land in the State and County aforesaid, in the City of Greenville, on the North side of U. S. Super Highway No. 29, being known and designated as Lot No. 10, on plat of University Park by Dalton & Neves, Engineers, November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of said Super Highway at the joint front corner of Lot Nos. 10 and 11 and running thence with the line of Lot No. 11 N 37-34 W 200 feet to an iron pin on a 20 foot alley; thence with said alley N 52-26 E 100 feet to an iron pin, joint rear corner of Lots Nos. 9 and 10; thence with the line of Lot No. 9, S 37-34 E 200 feet to an iron pin on side of said Super Highway; thence with said Super Highway S 52-26 W 100 feet to the point of beginning and being a portion of the land conveyed to the grantors by deed recorded in the aforementioned R.
