All my undivided one-half interest in and to all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, with buildings and improvements thereon, being at the northwest corner of the intersection of Mount Vista Avenue and Smith Street near the City of Greenville, and known as a part of Lot No. 6 on plat of property of D. T. Smith made by C. M. Furman, Jr., Engineer, March 5, 1923, recorded in the R.M.C. Office for Greenville County in Plat Book "F", Page 108, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin at the northwest corner of the intersection of Mount Vista Avenue and Smith Street and running thence with the west side of Smith Street, N. 25-40 W. 150 feet to an iron pin; thence with other property of Lydia D.
