

all that piece, parcel or lot of land in ------Greenville--- Township, Greenville--

County, State of South Carolina, on Darlington Avenue between Berkley Avenue and Dykeson Avenue, in the ans ouci section of Greenville County, about two miles north of the City of Greenville, said lot having the following lines, courses and distances, to wit:-

Beginning at an iron pin on the southern edge of a five (5) foot sidewalk running along Darlington Avenue, said pin being the joint front corner of lots numbered eight (8) and nine (9); and running thence along the southern edge of said sidewalk, N. 43 to E., sixty (60) feet, to an iron pin, joint front corner of lots seven (7) and eight (8); thence along the western line of lot seven (7), 5. 47-00 E., one hundred and forty-one (141) feet, to an iron pin, joint rear corner of lots seven (7) and eight (8); thence along the rear line of lot five (5), 3. 43-00 W., sixty (60) feet, to an iron pin, joint corner of lots eight (8) and nine (9); thence along the eastern line of lot nine (9), h. 47-00 ..., one hundred and forty-one (141) feet to an iron pin, the beginning corner, said lot being known and designated as lot numbered eight (8) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "R" at page 127, which plat is hereby referred to and made a part hereof.

Paid property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefore, and shall be effective for a period of twenty-five (25) years from the date hereof:-

- (1) Said property is to be used for residential purposes only.
- (2) No residence is to be erected thereon at a cost of less than five thousand dollars (\$5,000.00.).
- (3) No house is to be erected thereon nearer the southern edge of said sidewalk running along Darlington Avenue than twenty (20) feet.
