

Glenn R. Wright and Ruth M. Wright All that certain lot of land in Greenville County, Gantt Township, State of South Carolina, known and designated as Lot No. 24, according to plat of property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, said lot having the following metes and bounds as shown on plat made by Dalton & Neves, Engineers, March, 1947, andrecorded in the R. M. C. Office for Greenville County in Plat Book S, page 7:

Beginning at an iron pin on the southern side of Glennwood Lanc at the joint front corner of Lots 23 and 24, and running thence along Glennwood Lane, N. 75-42 W. 35.6 feet to a point; thence S. 71-34 W. 27 feet to a point; thence S. 38-50 W. 182 feet to a point at the rear corner of Lot No. 8; thence along the rear line of Lots 8, 9 and 10 S. 75-49 E. 133.7 feet to a point at the rear roar line of Lots 8, 9 and 10 S. 75-49 E. 133.7 corner of Lot No. 23; thence along the line of Lot No. 23, N. 14-18 E. 180 feet to point of beginning, being the same property conveyed to Louis C. De-Lucca by deed of Woodfields, Inc. datedJuly 20, 1848 and recorded in the R.M.C. Office for Greenville County in Deed Book 354, page 43.

As a part of the consideration for this deed, the grantee here n expressly assumes and agrees to pay the balance due on the following notes and mortgages: (1) Note and mortgage executed by Woodfields, Inc. to The Peoples Mational Bank of Greenville, S. C. on May 29, 1948 in the amount of \$7,000.00 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 390, page 257, the balance due now being \$6,819.27. (2) Note and mortgage executed by Louis C. DeLucca to The Peoples National Bank of Greenvile, S. C. for 1,1 C.00, recorded in Mortgage Book 395, page 277 in the R. M. C. Office for Greenville County, the balance now owing being the sum of \$1,015.33.
