to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Charles R. Atkins, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being at the Northeast corner of the intersection of Parkins Mill Road (sometimes referred to as Dakota Avenue) and Service Drive, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot No.2 on Plat of George N. Beattie and Eleanor G. Beattie, made by Piedmont Engineering Service June 27, 1949, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book V, page 193 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast edge of the Parkins Mill Road at joint front corner of Lots 1 and 2, and running thence along the line of Lot 1, S. 50-47 E. 141.4 feet to iron pin; thence along the line of Lot 3, S. 37-55 W. 66 feet to iron pin on the Northeast edge of Service Drive; thence along Service Drive N. 50-22 W. 108.6 feet to iron pin; thence continuing with Service Drive along a curved line (the chord being N. 9-42 W. 37.9 feet) to iron pin on the Southeast edge of Parkins Mill Road; thence along Parkins Mill Road N. 30-59 E. 40.6 feet to the beginning corner.

Being part of the same property conveyed to me by B. H. Trammel by deed dated August 26 1949, recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 391 page 6.

Grantee is to pay 1949 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

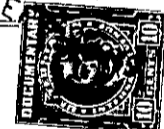
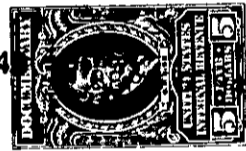
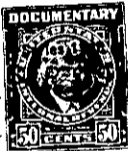
