

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the South side of Hilltop Avenue, in a Section known as Sans Souci, and being known and designated as Lot No. 7 of the property of H. J. Martin, as shown on Plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book G at Page 139, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the South side of Hilltop Avenue at the joint corner of Lots Nos. 7 and 8, which point is 150 feet west of the Southwest corner of the intersection of Hilltop avenue and Edwards Street, and running thence along the joint line of Lots Nos. 7 and 8, S. 17-00 W. 140.3 feet to an iron pin at the joint rear corner of said lots; thence N. 65-36 W. 70 feet to an iron pin; thence N. 61-36 W. 26 feet to an iron pin at the joint rear corner of Lots Nos. 6 and 7; thence along the joint line of said Lots Nos. 6 and 7, N. 33-00 E. 143.6 feet to the joint corner of said Lots Nos. 6 and 7, on the South side of Hilltop Avenue; thence along the line of said Hilltop Avenue, following the curvature thereof, S. 60 E. 57.5 feet to the beginning
