

All that certain parcel and lot of land situate, lying and being in South Carolina, Greenville County, Chick Springs Township, and being a part of what is known as Piedmont Park and having the following metes and bounds, to wit:

BEGINNING on the West side of Rutherford Road at an iron pin which pin is 190 feet from the Northeast interesection of Rutherford Road and Park Avenue and running themce N. 74-30 W. 7.1 feet to iron pin; thence continuing on the same course 195 feet to iron pin; thence N. 14-12 E. 95 feet to iron pin; thence S. 74-30 E. 195 feet to iron pin on the bank; thence continuing in the same direction 8.1 feet to iron pin on the West side of Rutherford Road; thence with Rutherford Road line S. 15-30 W. 95 feet to the beginning corner, and being the 3rd. lot going northeast from the intersection of Park Avenue along the Ratherford Road as shown by a plat prepared by R.
