in consideration of the sum of One Thousand Twenty-five and No/100- - - - - (\$1025.00)- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. E. Holton, his Heirs and Assigns forever,

"All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being shown as a portion of Lot No. 19 on Plat of the property of Vance Edwards, recorded in Plat Book P at Pages 128 and 129, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeastern side of the right-of-way of Super-Highway No. 29, said pin being at the center point of the front line of Lot No. 19, and running thence S. 47-15 E. 386 feet to iron pin on Lee Road; thence with the Northern side of Lee Road, S. 72-33 W. 57.97 feet to iron pin; thence N. 47-15 W. 357 feet to iron pin on the right-of-way of Super-Highway No. 29; thence with said right-of-way, N. 42-52 E. 50 feet to the point of beginning."

Said premises being a portion of the same conveyed to Grady T. Smith and C. E. Hellams by Joseph V. Edwards by deed recorded in Book of Deeds 334 at Page 276; the said Grady T. Smith having conveyed his one-half interest to the Grantor by deed of even date to be recorded.

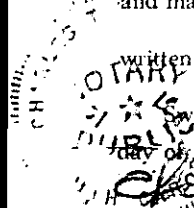

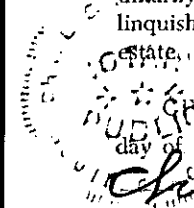
