(\$750.00) Dollars  
to in hand paid at and before the sealing of these presents  
by Lewis M. Henderson and Edith K. Henderson

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents  
do grant, bargain, sell and release unto the said Lewis M. Henderson and Edith K. Henderson, their heirs and assigns, forever:

All that certain piece, parcel or tract of land, situate, lying  
and being in Greenville County, State of South Carolina on the north  
side of Willardale Circle, being shown as all of tract 10 on plat of  
property of J. H. Black prepared in December 1947 by Walter Jones,  
Engineer, (Addition to plat, dated June 1949) which plat is recorded  
in the R. M. O. Office for Greenville County, S. C. in Plat Book "C",  
page 59 and lying according to said plat to the following notes and  
bounds, to-wit:

BEGINNING at an iron pin on the north side of Willardale Circle,  
at the southwest corner of tract 5; thence along the line of tract 5  
to an iron pin; thence S 78° 23' East to an iron pin; thence S 23° 13' 30" East  
to an iron pin; thence S 57° 11' 30" East to an iron pin; thence  
S 41° 57' 15" East 55 feet to an iron pin; thence S 45° 55' 15" East 66 feet to an  
iron pin, on the north side of a 4-foot road which road is a conti-  
nuation of and lying between the east side of the east lot east side of  
Willardale Circle as shown on the above plat; thence along the north  
side of said 4-foot road S 76° 11' 30" East 114 feet to an iron pin on the  
north side of Willardale Circle; thence S 76° 11' 30" East 114 feet to  
an iron pin; thence S 21° 55' 15" East 166 feet to an iron pin; thence continuing  
along the north side of said Willardale Circle S 76° 11' 30" East  
to an iron pin; thence S 76° 11' 30" East 114 feet to an iron pin; thence  
S 76° 11' 30" East 114 feet to an iron pin, the point of beginning.
