That R. E. Hughes in the State aforesaid, in consideration of the sum of One Thousand One Hundred Fifty and No/100 - - - - - DOLLARS,

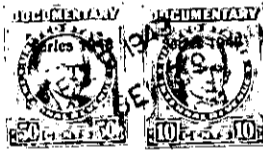

All that certain piece, parcel or lot of land situate, lying and being on the Southwest side of Longview Terrace, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 33 on Plat of Forest Heights, made by Dalton & Neves, Engineers, June 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", page 71, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Longview Terrace at joint front corner of Lots 32 and 33 and running thence along the line of Lot 32 S. 26-55 W. 160.8 feet to an iron pin; thence along line of Lot 83 S. 79-50 E. 124.2 feet to an iron pin on the West side of East Faris Road; thence along East Faris Road N. 20-10 E. 100 feet to an iron pin; thence continuing along East Faris Road along a curved line (the chord being N. 18-05 W. 35.4 feet) to an iron pin on the Southwest side of Longview Terrace; thence along Longview Terrace N. 63-05 W. 82 feet to beginning corner.
