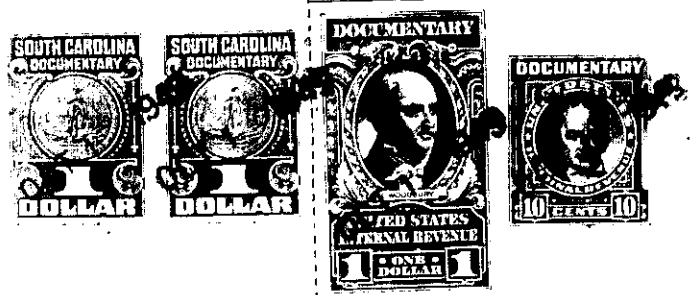

KNOW ALL MEN BY THESE PRESENTS, That Greenville Home Builders, Inc.,
a corporation chartered under the laws of the State of South Carolina,
and having its principal place of business at
Greenville in the State of South Carolina for and in consideration
of the sum of Five Hundred Twenty-five and 18/100 (\$525.18) Dollars,
and the assumption of two (2) mortgages

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee
hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and
released, and by these presents does grant, bargain, sell and release unto Edward W. Backow,
his Heirs and Assigns:

All that certain piece, parcel or lot of land, with the buildings and improvements
thereon, lying and being on the North side of Reid Street in the City of Green-
ville, South Carolina, being shown as Lots 11, 12 and part of Lot 13, Block "H", Con-
tention "H", Unit 2 on the Plat of Stone Station, recorded in the R&D Office
for Greenville County, S. C., and having according to said Plat the following
metes and bounds, to-wit:

Beginning at an iron pin on the North side of Reid Street at a point 17 feet West
of the intersection of Reid Street and Druid Street and thence N. 11° E. 150
feet to a stake on the line of Lot 5; thence along the line of Lot 5, S. 75°
38' W. 75 feet to an iron pin on line of Lot 12; thence along the line of Lot 12
S. 11° - 22' W. 150 feet to an iron pin on the North side of Reid Street; thence
along the North side of Reid Street S. 75° - 38' W. 75 feet to the point of begin-
ning.
