Know All Men by These Presents:

That Harold B. McKinney in consideration of the sum of Ten Thousand and No/100 - - (\$10,000.00) - - - - - DOLLARS, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas N. Walker, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of Carolina Avenue in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 10, Block L, Section 1 on Plat of East Highlands Estates made by Dalton & Neves, Engineers, April 1940, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book K, pages 35 and 36 and having according to said plat and a recent survey made by R. V. Dalton, Surveyor, September 24, 1949, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Carolina Avenue at joint front corner of Lots 10 and 11 of Block B said pin being 255 feet in a Northwesterly direction from the point where the Northeast side of Carolina Avenue intersects with the Northwest side of Wait Street and running thence along Carolina Avenue N. 31-33 W. 85 feet to an iron pin; thence along the line of Lot 9 N. 79-25 E. 173.5 feet to an iron pin on the Southwest edge of a 5 foot strip of land reserved for utilities; thence along the Southwest edge of strip land reserved for utilities S. 32-23 E. 60 feet to an iron pin; thence along line of Lot 11 S. 71-13 W. 167.2 feet to an iron pin on the Northeast side of Carolina Avenue the beginning corner.

This is the same property conveyed to me by deed of M. W. Fore, dated February 6, 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 286, page 357.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

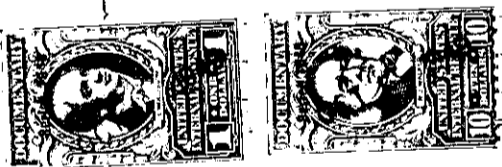
