That I, G. B. Lee in the State aforesaid, in consideration of the sum of Twelve Hundred and No/100 (\$1200.00)- DOLLARS,

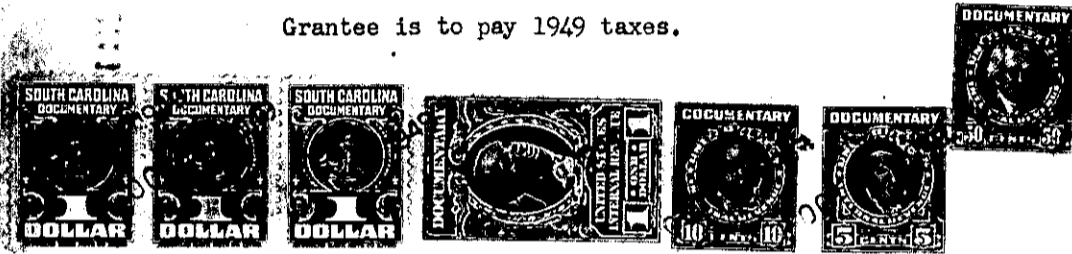
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Fair Heights Baptist Church, its successors and assigns,

All those three certain tracts or lots of land in Butler Township, Greenville County, State of South Carolina, being shown as lots Nos. 2, 3 and 4 on Plat of property of W. L. Hanvey made by W. J. Riddle in September 1948, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of a new street, which pin is 220.7 feet from the intersection of said new street and Dakota Avenue (formerly Parkins Mill Road), and running thence with the Southwest side of said new street, N. 59-40 W. 180 feet to an iron pin at corner of Fair Heights property; thence with the line of said property, S. 31-37 W. 205 feet to an iron pin in line of property owned by W. W. Wingo; thence with the line of the Wingo property, S. 59-40 E. 180 feet to an iron pin at corner of lot No. 1 as shown on said plat; thence with line of lot No. 1, N. 31-37 E. 205 feet to point of beginning.

Said premises being the same conveyed to the grantor by W. L. Hanvey by deed recorded in Book of Deeds 376 at Page 375.

Grantee is to pay 1949 taxes.
