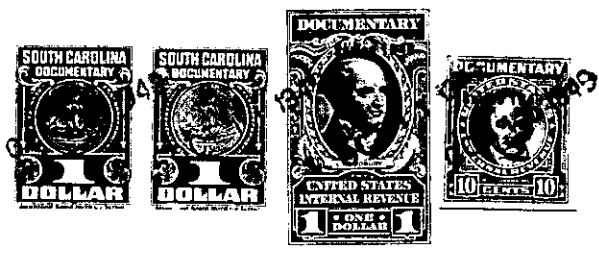
That I, Calvin T. Fowler in consideration of the sum of Seven Hundred (\$700.00) in the State aforesaid, DOLLARS,
