BEGINNING on the northwest corner of Hart Street and Carolina Avenue, and running thence with Carolina Avenue, N. 15-10 W., 70 feet to joint front corner of Lots Nos. 30 and 31; thence with the line of said lots, S. 74-30 W. 100 feet to a point in line of the Piedmont and Northern right-of-way; thence with said right-of-way in a southerly direction, 70.4 feet to a point on the north side of Hart Street; thence with Hart Street, N. 74-30 E., 111.2 feet to the point of beginning.

This is identically the same lot as conveyed to J. McCraw by H. K. Townes, et al., by deed dated May 11, 1921, recorded in the RMC office in deed book 62 at page 120, the said J.
