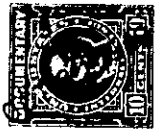

Know All Men by These Presents:

That I, Sadie K. Davis in consideration of the sum of Fourteen Hundred, Ninety and no/100 in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Grace K. Styles

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Longview Terrace, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 47 on Plat of Forest Heights, made by Dalton & Neves, Engineers, June, 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", page 71, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Northeast side of Longview Terrace, at the joint front corner of Lots Nos. 46 and 47, and running thence along the line of Lot No. 46 N. 20-44 E. 164 feet to an iron pin; thence N. 60-06 W. 30.12 feet to iron pin; thence along the line of Lot 43 S. 20-44 W. 168.8 feet to iron pin on the Northeast side of Langview Terrace; thence along the Northeast side of Langview Terrace S. 69-16 E. 80 feet to the beginning corner.

This is a portion of that property conveyed to R. E. Hughes by deed of Hughes Real Estate Company, dated April 29, 1942, recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 380, page 239; being the same property conveyed to the grantor herein by deed of R. E. Hughes dated August 17, 1949 and recorded in the R. M. C. Office for Greenville County in Deed Book 388, at page 137.

This property is conveyed subject to the restrictive covenants and building restrictions applicable to Forest Heights which are recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 207, page 256.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
