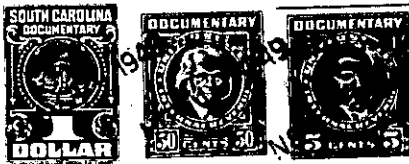

Seaborn and Lois Seaborn, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the Southwest side of Courtney Circle east of the Old Buncombe Road near Greenville in Greenville County, S. C., being shown as Lot 66 on plat of Casa Loma Estates made by Piedmont Engineering Service in October, 1947, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book S, page 65 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Courtney Circle at joint front corner of Lots 65 and 66 and running thence along the line of lot 65 S. 70-26 W. 180 feet to an iron pin; thence N. 19-34 E. 80 feet to an iron pin; thence along the line of Lot 67 N. 70-26 E. 180 feet to an iron pin on the Southwest side of Courtney Circle; thence along Courtney Circle S. 19-34 E. 80 feet to the beginning corner.
