Eight Hundred and Seventy (\$870.00) Dollars

to US in hand paid at and before the sealing of these presents by M.M. Bramlett and Bessie Bramlett

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M.M. Bramlett and Bessie Bramlett their heirs and assigns:

all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the West side of a surfaced road between Fairview Church and Chick Springs, designated as Lots Nos. 8 and 9 on a plat of the property of Fairview Baptist Church by H.L. Dunahoo, Surveyor, dated October 26, 1949, and having the following courses and distances, to wit: Beginning at a stake on said road, corner of Lot No. 7; and running thence along said road, S. 13.35 E. 100 feet to iron pipe, corner of Nodine land; thence along line of Nodine property, N. 74.10 W. 203 feet to stake, corner of Lot No. 5; thence along the line of Lots Nos. 5 and 4, N. 9.50 E. 84 feet to stake, corner of Lot No. 7; thence along the line of Lot No. 7, S. 74.10 E. 162 feet to the beginning corner.
