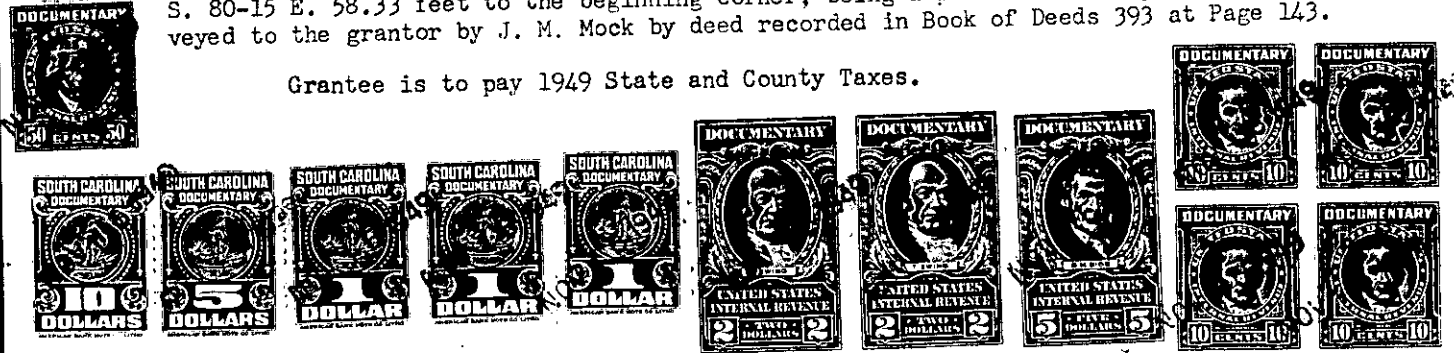
That I, J. H. Mauldin in the State aforesaid, in consideration of the sum of Nine Thousand and No/100 (\$9000.00)----- DOLLARS,

Hamrick and Mary Brown Hamrick, their heirs and assigns forever:

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northwest corner of Mountain View Avenue and Townes Street Extension, in the City of Greenville, and being a portion of lot No. 21, of Block A, as shown on plat of Buist Circle, recorded in Plat Book C, at Page 10, and described as follows:
