

BEGINNING at a stake on the Southern side of Beck Avenue, 317.5 feet Lest from the Old Augusta Road at corner of lot No. 260, and running thence with the line of said lot, 3.00-13 1. 140 feet to a stake, corner of lot No. 235; thence with the line of said lot, 3.89-47 W. 60 feet to a stake at corner of lot No.258; thence with the line of said lot, M.00-13 W.140 feet to a stake on Beck Avenue; thence with the Southern side of Beck Avenue, II.89-47 E. 60 feet to the beginning corner.

As a part of the consideration for this deed the Grantees assume and agree to pay a balance of \$6,652.37 due on a mortgage executed by the Grantor to C. Douglas wilson & Co., dated June 27, 1947, in the original sum of \$7,400.00, and assigned by C.D.uglas firson & Co. to the Metropolitan Life Insurance (capany on June 27,1947, said mortgage and the assignment thereof being recorded in the AIC Office for Greenville County in Mortgage Bock 366, at page 61.
