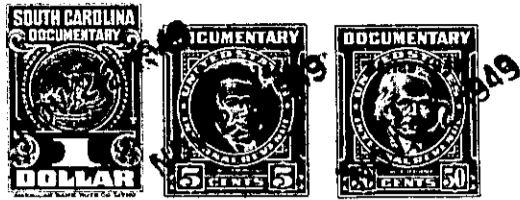

presents do grant, bargain, sell and release unto the said Robert Anderson, his Heirs and  
Assigns forever

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, near St. Mark M. E. Colored Church, being bound-  
ed on the north and east by lands of St. Marck Church, on the south  
by lot No. 10 of the King Greer Estate and on the west by lot No.  
12 of the King Greer Estate lands, and being shown as lot No. 11  
on Plat of Property of King Greer Estate prepared by J. Earle Free-  
man, Surveyor, March 1938, and having the following courses and  
distances, to wit :-

Beginning on an iron pin, corner of St Mark Church lands, and  
runs thence S. 24 1/4 W. 1.24 chs. to an iron pin, joint corner of  
lots 10 and 11 and on the Church property line; thence with the

11 and 12; thence with the dividing line of lots 11 and 12 N. 6-00 E.

pin, Church lot corner; thence with the church lot line S. 50-00 E.
