All of our undivided right, title and interest in, of and to:

all that piece, parcel or lot of land in Highland Township, Greenville

County, State of South Carolina, on west side of Middle Tyger River, the same being the middle portion of the S. D. Whelchel Home Tract, containing Forty Five and 1/5 (45 1/5) acres, more or less, being the same tract of land conveyed to W. J. Reid by S. D. Whelchel by deed dated December 18, 1889, recorded in R. M. C. office for Greenville County in Vol. VV at page 463, and reference is hereby made to said deed for more particular description.

ALSO, all that other piece, parcel or tract of land in Highland Township, Greenville County, State of South Carolina, being all that tract of portion of land situate, lying and being on the west side of Middle Tyger River, containing Nineteen and 25/100 (19.25) acres, more or less, and having such metes and bounds, courses and distances as are fully set forth in deed of said property made by A.
