Know All Men by These Presents:

That I, James W. Hicks, of Greenville County, South Carolina, in the State aforesaid, in consideration of the sum of Five Hundred Sixty Five (\$565.00) - - - - - DOLLARS, and the protective covenants hereinafter mentioned, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Geddies L. Attaway, his heirs and assigns,

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, about five miles south of Greenville Court House, east of Augusta Road, being shown and designated as Lot Number Sixteen (No. 16) on northern side of Eastview Drive on plat of survey of subdivision known as "Clearview Heights" by M.H. Woodward, R.E., Dec., 1945, recorded in Plat Book "P" at page 1, in R.M.C. office for said County, and, according to said plat having the following metes and bounds, to-wit:

BEGINNING at i.p., on northern side of Eastview Drive, joint front corner with Lot No. 15, and running thence N. 18-04 W. 250.6 feet along eastern line of Lot No. 15 to i.p.; thence N. 68-18 E. 86.4 feet to i.p., joint rear corner with Lot No. 17; thence S. 18-04 E. 256.3 feet along western line of Lot No. 17 to i.p. on northern side of Eastview Drive; thence S. 71-56 W. 86.2 feet along northern side of Eastview Drive to point of beginning.

This is a part of a tract of 18.91 acres conveyed to me by Willis, and others, by deed dated Nov. 3, 1944, recorded in Vol. 269 at page 179 in R.M.C. office.

This property is conveyed, however, subject to the protective covenants as set forth and recorded in Vol. 396 at page 141 in said R. M. C. office.

This property is conveyed subject, also, to an easement and right of way across the rear of said lot of land, Ten (10) feet in width at all points, which is expressly reserved by Grantor for the purpose of an alleyway extending eastward from the Augusta Road, if said alleyway is constructed and established before the year 1952.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
